# **ZONING REPORT**

# **APPARATUS 2113**

Chief Reed reported that Engine 2113 maintenance was completed with the following repairs needed. Quick release valve for park brakes is leading air, Right hand outer tie rod end boot is torn, on board battery charger is inoperative, auto eject is inoperative, steer axle brake clevis pins are seized in the closed position, primer pulled 22" hg, radiator cap leaking, HVAC mode selector is stuck in defrost mode, fast idle switch is inoperative, left front and rear compartment lights are inoperative, recommend replacing pump inlet screens with the sacrificial type, master pressure gauge reads vacuum at atmospheric pressure, tachometer in dash reads significantly different from tachometer in pump panel, fuel tank is heavily corroded, tires are past their NFPA 7 year replacement date, manual pump shift inoperable and A/C not functioning.

Dave Duncan reported receiving a call from a resident about neighbor wanting to put a horse on property and the resident does not think there is enough room for a horse. No zoning on how much acreage is needed to have a horse.
