FULL TIME FIRE DEPARTMENT/EMS

Ed Samec had a proposal for a fulltime fire/EMS personnel. The person would work 8 hour days, 5 days a week. The person would have to be a Paramedic / FF2. Salary would be \$40,000 annually with medical coverage. The person would have to be approximately 30 years of age, live in Portage County, non-tobacco use, and the township would offer insurance coverage only to the employee. The person would accumulate sick time at 4.6 hours earned per 80 hour service. The personnel would receive government holidays off and if needed to work would get time and a half pay. This is a proposal that Ed Samec brought to the table.
